The Finer Points

I'm guessing everyone has started using their air conditioners. I'm still having trouble with

mine in the Roadster... it always seems to stop working when I stop at a traffic light. The other day I parked my DeLuxe Roadster next to another '30-'31 Model A, and I was shocked by how much more curved the front bumper is.

I've known for a while the front bumper braces were reproductions, but sometimes it just takes a direct comparison to realize just how wrong they are. The bumper on a '30-'31 Model A is supposed to be relatively flat. Ford did this to give the cars a more rugged and



sporty appearance. The below photos show just how different the reproduction braces are from the originals especially how much more curved it is.



Bumper arms were square on the front end from the beginning of production until early 1931 when rounded ends began



to appear. It is very common to see 1930 or before cars with 1931 bumper arms on them. The edges of the brace are more rounded on the original, and frequently a "C" is cast into them. (Original bumpers also tended to have a "C" cast into them, but not always.) Additionally, the original brace holds the bumper well away from the tires. There should be at least four inches between the tire and the end of the bumper.

It only took about 30 minutes to change out the braces on my '31 DeLuxe. Believe it or not, this is the second time I've changed out bumper braces! My '28 Roadster had '31 braces on it when I first purchased it, and I picked up an original correct pair for the 1928 at Model A Day last year. In 1930 and 1931, the bumper arms were attached with special studs which were painted glossy black while the nuts and lock washers remained unfinished. Also, the back part of the bumper clamp, the backing plate, the heavy lock washer, and the nut were painted in black enamel.

The next two photos show the finished product. The bumper is wonderfully straight now just as it should be! Also, I have a rule on my cars: I do not put the hardware back on unless it is the correct finish.

So, that added to the amount of prep time for getting this project going.

So, go out into the garage and look over your car a little more! Who knows maybe you'll figure out your bumper arms are correct, and you were one up on me this whole time and didn't even know it! You know what makes the Model A so fun? Merely the fact that it's a Model A so there is always something to be done.






My Latest Model "A"

Recently, I finally got the opportunity to purchase a February 1930 Roadster I've been dreaming about for about two and a half years. We refer to this body style as a "Standard" today; however, when it was new, the DeLuxe did not yet exist since it wasn't introduced until August of 1930. So, it is simply just a Roadster, and it is about as plain as it would have been when it drove off the factory floor some 90 years ago.

Over two and a half years ago in 2018, I bid on this car on eBay. Unfortunately, I was way outbid, and I figured that was the end of that. In September 2018, my parents and I went to our first Model "A" Day at the Gilmore museum. As usual, my dad and I scouted (can I say "scouted"?) out the parking lot of the hotel looking for nice cars. It was a bit dark, but we came upon this Roadster.

Looking it over in the dark, I told my dad that I was pretty sure this was the car I had bid on a few months back. The owner, Todd, wandered over and started talking to us. He was very nice and told us all about the car. Then, he mentioned it was for sale because the eBay buyer had backed out. My dad and I told him that I'd like to have the car, but I really didn't see how I could justify it since I already owned a 1929 Phaeton and a 1931 DeLuxe Roadster. Especially since Mom kept telling me there was, "no more room at the inn!" I dreamed about the car that night, and I looked it over really well the next day in the sunlight. It was really nice, but I still didn't see how I could make it work. In 2019, we went to the MARC National Meet in Dearborn, and we participated in Fine Point Judging for the first time. We had a blast! Believe it or not, it was a family event! Even Mom got in there and helped us clean Dad's 1928 Roadster for the show before she scurried off for shopping. Around noon, we took a lunch break, and Dad and I sat at a random table. I looked across the



table, and low and behold Todd was sitting across from us. I asked if the Roadster was still for sale. To my surprise, he said it was. We joked about how I really needed the car. By this time, I had purchased a 1928 Roadster despite the claims about there not being "room at the inn." Anyway, we finished lunch, and I tried to put the 1930 model out of my mind so I could finish judging the brakes on the fine point cars.

Around November of 2019, a random guy kept stopping by Dad's shop asking about buying my 1928 Roadster. I wasn't really interested in selling it to him since I had spent about a year transforming it from a run of the mill 1980's restoration to a nice reliable driver. After a couple of times of this guy stopping by, my dad finally said, "You know if you sell this car, we will have room for the 1930 Roadster." A light bulb went off, and I was ready to sell. First, I called Todd to ensure the 1930 was still available, and it was. I made up my mind... I was going to purchase this car.



Todd wanted me to wait until the snow cleared up a bit since he lived in Indiana. I was okay with that since in the meantime, we could sell the '28. Everything seemed to be going my way, but of course this is where things started to fall apart. The buyer for the '28 backed out, but that was alright. I didn't really need to sell it so long as I could convince my mom there actually was "room at the inn." I mean who doesn't want to own a Model A of every year model? The snow in Indiana, however, was a different story. Apparently, it just kept snowing which meant I was unable to go look at it again.continued next page

Winter seemed to drag on and on while we slowly approached March. We were scheduled for a trip to Egypt, and I told Todd I would plan to come look at the Roadster in mid-March when I got back. If I thought my plans fell apart before, they really fell apart when the coronavirus hit. We made it back to America, but everything was locked down.

I kept in touch with Todd, but it seemed I would never be able to head north since everything remained locked down. I was starting to think I wasn't destined to own this particular Roadster; however, restrictions started to ease a bit in early May. I tentatively made plans to go north the last week of May when riots hit nearly every major city in the US. Finally, I made it up in mid-June. To be precise, we arrived three days before my birthday. Happy Birthday to me! I purchased the car despite Todd's wife not wanting him to sell it, and we were finally headed home!

The Roadster was restored in the early 1990's for fine point judging; however, it fell short of becoming a high point car due to some easily correctable small details. Nevertheless, the car is magnificent. What I like most about it is that it's still a Standard. No cowl lights. A trunk instead of a rumble seat. Standard windshield and top bows. The paint scheme is correct for the month and year: Black with Vermillion (Red) pinstripe. Additionally, the interior is correct with Black-Brown trim. Eventually, I hope to restore it as a fine point car, but in the meantime, I think I'll just have fun with my long-awaited Roadster!

TO MY TULSA FORD MODEL A CLUB MEMBERS

In January 2001, Charlene & I joined the Club. The fellowship with other Ford Model A enthusiasts was over whelming! I was restoring a 1931 coupe deluxe. Any time I needed advice or help all I had to do was ask for it. Through all these years the members not only showed concerns for my car, but for Charlene and me personally.

In August 2019 I had a knee replacement. In less than a year June 2020 I had foot surgery. I have missed out on the club activities for a year. But the Club members have kept our fellowship strong with phone calls and letters. I am doing very well on my foot surgery so far. The Doctor this week told me I can put my foot on the floor in the next week or two. He placed screws and staples in all my left foot joints. They should bound together so they will not bend. There was no cartilage between the bones. I thought I would tell you of one episode of my ankle fusion surgery.

When I woke up in the recovery room I had a boot type cast on. They told me not to take it off. It has six two inch wide belt straps holding it in place. There is a two inch wide steel brace rod on each side. They come from the foot plate to the top of the boot. The boot feels like it weights five pounds. At the front top part of the boot is a blue two inch half ball sticking out. I assumed it was a cushion for my leg to rest on. Charlene got me a little knee scooter. It lets me put my knee and leg on it. It is a great help going to the bathroom.

I was home about four days when my foot started hurting real bad! It felt like my foot was being squashed. I called the Doctor. The nurse told me I could loosen the belt straps a little to relieve some pressure from swelling. I kept loosening them for a week or so. Then one day I took the straps off and took my foot out of the boot. It felt good. But when I tried putting the boot back on, my foot wouldn't go all the way back in it! That's when I noticed the boot had a lining inside it. It was full of air. It was inflated so much I couldn't get my foot in to it.

That is when all my technical training as an Air Force trouble shooting B-47 Bomber Crew Chief and a Model 'A' shade tree mechanic paid off! I noticed almost completely hidden next to the two inch blue cushion half ball at the front top of the boot, there was a little knob. I turned it. The air pressure went out of the boot. Wow! Now I can get my foot back into the boot. The problem was solved! The blue cushion pad was not a cushion pad; it is a push button air pump. Every time I laid my knee and leg on the scooter it was pumping air into the boot walls. I guess I should tell my Doctor he did a great job stitching up my incisions. The squashing from the boot air walls didn't pop the stitches loose! I now can control how much air pressure is in the boot. I hope I don't have any more surprises coming. I think I will tell the doctor they should explain to old people how to operate new high tech equipment when they put it on them. In a few months I hope to be able to physically fellowship with my Club members again.

Please keep praying for America and our leaders. Ask God to keep His protective hands over our families though this coronavirus pandemic.
