The Finer Points By Chris Duval

Fall weather is definitely upon us as evidenced by the cooler nights we've been having. It's time to put on the side curtains, or if you have a fancy car, just roll up the windows. Even though less motoring may be ahead, it will give me much needed time to continue working on the 400-A. The chassis is moving along fairly quickly. Hopefully, it will be time to begin thinking about the sheet metal. So, let's take a brief walk through Area 13: Sheet Metal.

I count myself very lucky with the quality of sheet metal that came with the motorcar. Jim owned the car for 38 years and collected parts for most of that time. Many of the parts he collected are New Old Stock (NOS). I find NOS parts to be particularly fascinating because they give a great glimpse into the manufacturing process when these cars were new. One example that springs to mind is the right rear sedan fender that came with the car. Below is an overview photo of my NOS sedan fender.



The paint isn't too bad considering it's 91 years old! The overview is great, but it doesn't show the details that were present when the cars were new. By the way, most of these details must be present on Fine Point cars. If they are not present, the part has most likely been over-restored. First let's look at the carriage bolt hole for the fender brace.

First up is a detailed view of the fender brace area. Can you see how defined the knurling is along the edge of the fender? It varies slightly in height, but it is present all along the edge, and it can easily be felt. On a restored fender, it is very common for the knurling to be filled in and smooth. To the left of the square hole, there is a small spot that looks like the paint is messed up. That is actually a spot weld holding the fender bracket reinforcement in place. In person, both spot welds can be seen and felt. Once again, it is very common for these spot welds to be smoothed over during the restoration process. Smoothing the fender up too much would most likely result in an over-restored deduction. Let's flip the fender over to see the other side of this hole.



Shown above is the inside view of fender bracket reinforcement. To the best of my knowledge, reproduction fenders are sold without these being installed. As



a result, reproduction fenders must be modified to properly fit the reinforcement. To the right of the reinforcement, you can see the flange is cut away to allow ample room. On reproduction fenders, the flange is not cut away. During the Fine Point process, the judges feel the inside of the

Address to Fellow Countryment

THE WHITE HOUSE November 11, 1919

A year ago today our enemies laid down their arms in accordance with an armistice which rendered them impotent to renew hostilities, and gave to the world an assured opportunity to reconstruct its shattered order and to work out in peace a new and more just set of international relations. The soldiers and people of the European Allies had fought and endured for more than four years to uphold the barrier of civilization against the aggressions of armed force. We ourselves had been in the conflict something more than a year and a half.

With splendid forgetfulness of mere personal concerns, we remodeled our industries, concentrated our financial resources, increased our agricultural output, and assembled a great army, so that at the last our power was a decisive factor in the victory. We were able to bring the vast resources, material and moral, of a great and free people to the assistance of our associates in Europe who had suffered and sacrificed without limit in the cause for which we fought.

Out of this victory there arose new possibilities of political freedom and economic concert. The war showed us the strength of great nations acting together for high purposes, and the victory of arms foretells the enduring conquests which can be made in peace when nations act justly and in furtherance of the common interests of men.

To us in America the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service, and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of nations.

flange to determine if it is cut away for the reinforcement. If it is not, then it is a dead giveaway that the fender is a reproduction. The general consensus on reproduction parts is that they receive half points. Ouch! I think it is important to note that a reproduction fender can receive full credit if certain steps are taken to make it as close to an original as possible. Cutting away the inside flange is one of the many steps you must take. Next, let's take a closer look at the paint on the inside of the fender.



As you can see, the paint and finish on the inside of the fender is the exact same as on the outside. Exactly like the wheels we looked at last month, fenders were dipped in black enamel. Can you spot the paint runs? Before you ask... no, paint runs are not required or even wanted on a Fine Point car. However, I believe a run or two on the bottom side of the fenders will probably be forgiven. Then again, it may depend on the judge. As a point of reference, the runs in the above photo would run up on the fender once mounted to the car.


